

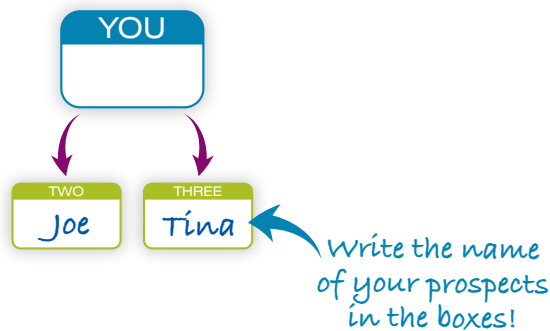

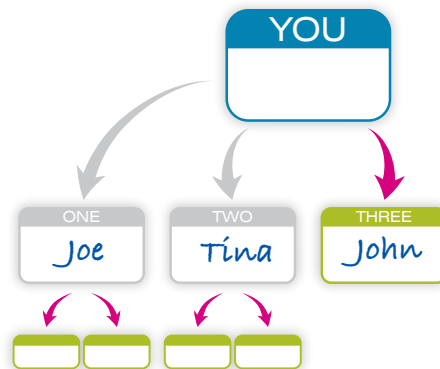

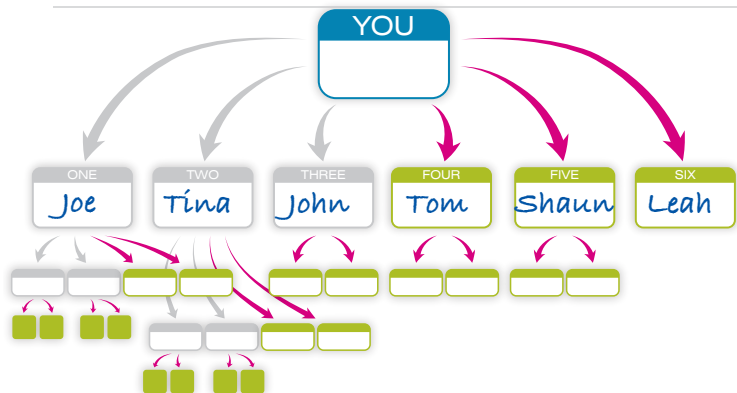

YOU — 1st Generation: 4 — 2nd Generation: 16 — 3rd Generation: 64 — 4th Generation: 256 = Total: 340

Stay in action with everyone ordering each month. This is what gives you stable long-term Residual Income. Now let's see what's possible if everyone is using and recommending the products for a total of \$200 each. That \$200 comes from everything they purchase for their own use, PLUS the combined sales of all of their customers.

That's **340 PEOPLE x \$200 = \$68,000** in TOTAL SALES.

You could earn an average of 10%³ on all of it. **\$68,000 x 10%³ = \$6,800**
